**Re: Complaint Against Dr. Deena Hinshaw and Dr. Verna Yiu**

---

The CPSA *Standards of Practice* under the heading of **Informed Consent** state that:

**A care provider must obtain consent and ensure that the patient is fully informed and understands any medical examination, procedure or treatment before it takes place.**

Both Dr. Hinshaw and Dr. Yiu have been involved in promulgating Public Health Orders or AHS Directives which have the effect of coercing citizens of Alberta to obtain Pfizer and Moderna COVID-19 injections against their will.

The *Standards of Practice* do not provide exemptions for this rule on the basis of the CPSA or CPSA Council holding the opinion that it is in the patient's best interest to be forced through loss of livelihood or denial of access to restaurants, sporting facilities or normal life; on the basis of the CPSA's own assessment of the health merits of being vaccinated or unvaccinated.

The simple fact that a patient says no and refuses to be vaccinated is the end of the discussion from the standpoints of medical ethics.

NO MEANS NO.

Given that our healthcare system is about to become overwhelmed as doctors, nurses, and healthcare workers of good conscience are either resigning their positions or being terminated for not being willing to abide by unethical Orders of Drs. Hinshaw and Yiu, time is of the essence with regard to this Complaint.
