Re: Illegal Access of Medical Files of Jeffrey Rath by Dr. Findley, Dr. Robinson and Jason MacDonald

This is in response to your correspondence advising that you will investigate my “allegations” concerning the illegal access of my personal medical records by College staff while I am actively representing Doctors being harassed and subjected to biased and discriminatory investigations by the College of Physicians and Surgeons (CPSA).

Please be advised that these are not “allegations”. The access to my personal medical files by College personnel without my consent is a fact.


Please find attached a copy of a letter from Dr. Daniel Botha with the exact particulars of the breach of my medical privacy by agents of the CPSA.

That this could happen in the midst of my acting as legal counsel in my capacity as an officer of the Court on matters where the mis-conduct of the CPSA is at issue is criminal in nature given that my personal medical files were not accessed as part of any normal, random practice review being carried out by the CPSA. This violation of my medical privacy appears either to have been conducted as an act of intimidation or as an attempt by agents of the College to derive blackmail material that could be used as leverage in the context of looming litigation in the Court of Queen’s Bench of Alberta with regard to the ongoing gross mis-conduct of the CPSA.

This matter should not be investigated by the CPSA. I respectfully request that this matter be referred to the Calgary City Police for criminal investigation.

Your file was accessed by Dr Ted Findley on April 3 at 17:38:56 on computer IP 70.65.254.136 with Tx ID 10119145 on my Med Access System

The second time was when Dr. Jeff Robinson and Mr Jason MacDonald showed up at my office on November 25 2021 and told me they are coming for an inspection of my files. I was not allowed to be in the room when they accessed the files.

As soon as they left I checked which files they open up and they open your file on

November 25 at 09:01:58 from the computer that they used IP 184.70.213.166 Tx ID 11162078

I contacted you directly after this to inform you from what happened.
