Dear Dr. Hinshaw, Dr. McLeod, and Dr. Yiu:

Re: Fluvoxamine for Outpatient Use

Please be advised that we have not received a response to our last correspondence with regard to the ability of physicians in Alberta to prescribe Fluvoxamine on an outpatient basis to patients who test positive for COVID-19.

We will be posting this letter, along with our last correspondence to you, on our website. We will further advise the physicians that requested that we correspond with you in regard to this matter that the College of Physicians and Surgeons, the Chief Medical Officer of Health and Chairman Yiu of AHS, do not object to the prescription of Fluvoxamine on an outpatient basis.

We would remind you that the Ontario Science Table approved Fluvoxamine for outpatient use on the 20th of December, 2021, on the basis that Fluvoxamine reduced COVID mortality by 90%.

We would again ask which of you are responsible for the 9 out of 10 COVID deaths that have occurred in Alberta since December 20, 2021, as a result of the CPSA and AHS not sending an urgent Notice to the Profession advising physicians and pharmacists in the Province of Alberta of the benefits of prescribing Fluvoxamine on an outpatient basis.

We would also inquire of the Minister of Health by copy of this letter what steps have been taken to secure an adequate supply of Fluvoxamine for outpatient use in Alberta.
